
Privacy Policy – ELSA Belgium

Definitions

Belgian network: ELSA Belgium, ELSA Antwerp, ELSA Brussel, ELSA Brussels, ELSA Hasselt, ELSA Leuven, ELSA Liège, ELSA Louvain-la-Neuve, ELSA Saint-Louis.

EEA : European Economic Area.

ELSA section: every single ELSA group at the international, national or local levels.

GDPR: Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC.

International Programmes: the Student Trainee Exchange Programme (STEP), the Summer and Winter ELSA Law Schools when it comes to the part of the organisation dealt by ELSA International, the John H. Jackson Moot Court Competition, the European Human Rights Moot Court Competition, the ELSA Delegations, the Legal Research Groups organised by ELSA International.

Scope of the policy

This privacy policy applies to any data processing made by ELSA Belgium when organising its events and activities. It also applies to any personal data that would have been sent to ELSA Belgium by another ELSA section.

Any data processing related to the International Programmes is made under the respective privacy policies of ELSA International.

ELSA Belgium could not be held responsible for any violation of the data protection laws and regulations occurring in the field of those programmes that would not have been foreseen by the present privacy policy.

This privacy policy also applies to the ELSA Law Schools organised by ELSA Belgium when it comes to the national aspects of the organisation of those latter. It shall prevail on that released by ELSA International for any data received or processed by ELSA Belgium as long as it is compliant with the International Terms & Conditions of the ELSA Law Schools.



General information

The processing of data by ELSA Belgium aims at:

- Organising our events by foreseeing the number of participants as well as their names, being able to contact them, to share the needed information with them and to inform them about our future events;
- Improving our events;
- Improving our network and training our new members;
- Managing our network by knowing who our past and present members are and being able to contact them for ELSA-related purposes (organisation and promotion of our events as well as invitation to be part of them, development of our Alumni association,...);
- Allowing you to exercise your rights according to the GDPR;
- Making statistics with anonymised data.

This processing mainly concerns the name, contact details, year and place of studies, the branch of law studied and positions in ELSA of our members and of people attempting to our events. However, any information needed for organisational purposes is likely to be processed.

Every processing we make is always based on the person's consent on the basis of Article 6.1 a) of the GDPR.

Therefore you can always refuse to share your data with us or withdraw your consent. However, this refusal or withdrawal could lead to the impossibility to let you attempt to our events or to become a member of the network.

Transfer of data

Your data are likely to be shared with the rest of the Belgian network if needed.

Your data will not be shared with ELSA sections located in third countries except when organising transnational events with other ELSA groups.

Your data are likely to be shared with ELSA International if needed for organisational purposes or legitimate reasons. When transferring the data to ELSA International we make sure that they offer a sufficient level of data protection. Furthermore, we will inform you of this transfer.

At any moment you can ask us whether your data has been transferred outside of the Belgian network, where it has been transferred when the transfer occurred. You can also ask our assistance to access the privacy policy of the concerned ELSA section.

We can not be held responsible if any other ELSA section within the EEA is not GDPR compliant and they should be held personally liable in case of any breach. This also applies to every ELSA section located in a country that has been considered as offering a sufficient level of protection by the European Commission through an Adequacy Decision.

Whenever your data has to be shared with another country than the above-mentioned ones, we make sure that the ELSA section offers a sufficient level of data protection.

Any transfer of data related to an International Programme falls under the Privacy Policies of ELSA International.

Your data will not be sent to any non-ELSA party without your explicit consent.

Duration of the processing

Your data will be kept as long as needed to organise the related event and for a maximum period of two years.

This does not apply to the data processed before the 1st of August 2019, which are going to be deleted or anonymised as soon as possible by the current Data Protection Officer of ELSA Belgium during the term 2019-2020.

The data related to our members will be kept as long as a specific demand has not been made to erase the data. This can be done by fulfilling [this document](#) or by contacting dpo@be.elsa.org.

Every information is likely to be anonymised and kept for statistic purposes with no limit of time.

Exercise of rights

Please be aware that you have the right to :

- Access your data at any moment;
- Modify and complete your data at any moment;
- Ask for the erasure of your data at any moment;
- Restrict the processing of your data at any moment;
- Transmit the data we processed to another processor;
- Withdraw your consent to the processing at any moment at the conditions stated above.
